## **Assistant Professor:**

### **Essential Qualification:**

- First Class Master's Degree in Business Management / Administration / in a relevant management related discipline or first class in two year full time PGDM declared equivalent by AIU / accredited by the AICTE / UGC;

Or

First Class graduate and professionally qualified Chartered Accountant / Cost and Works Accountant / Company Secretary of the concerned statutory bodies.

### **Desirable Qualification/Experience:**

- The candidate who has cleared the National Eligibility Test (NET) conducted by the UGC, CSIR or similar test accredited by the UGC like SLET/SET etc.
- An eminent scholar with a doctoral degree (Ph.D.) in the concerned or relevant discipline is desirable.

## **Associate Professor:**

### **Essential Qualification:**

- Consistently good academic record with first class marks (or an equivalent grade in a point scale wherever grading system is followed) in Master's degree in Business Management/ Administration/ in a relevant management related discipline or first class in two years full time PGDM declared equivalent by AIU/ recognized by the AICTE / UGC;

Or

First Class graduate and professionally qualified Chartered Accountant / Cost and Works Accountant / Company Secretary of the concerned statutory bodies.

- Ph.D. or Fellow of Indian Institute of Management or of an Institute recognized by AICTE and declared equivalent by the AIU.



- A minimum of eight years' experience of teaching / industry / research / professional at managerial level excluding the period spent for obtaining the research degree.

Or

- In the event the candidate is from industry and the profession, the following requirements shall constitute as essential requirements:

- Consistently good academic record with first class marks (or an equivalent grade in a point scale wherever grading system is followed) in Master's degree in Business Management/ Administration/ in a relevant management related discipline or first class in two years full time PGDM declared equivalent by AIU/ recognized by the AICTE / UGC

Or

First Class graduate and professionally qualified Chartered Accountant/ Cost and Works Accountant/ Company Secretary of the concerned statutory body.

- A minimum of ten years' experience of teaching industry/research / profession, out of which five years must be at the level of Assistant Professor or equivalent excluding the period spent for obtaining research degree. The candidate should have Professional work experience, which is significant and can be recognized at national/ international level as equivalent to Ph.D. and ten years managerial experience in industry/ profession of which at least five years should be at the level comparable to that of lecturer/ assistant professor.

## **Professor:**

### **Essential Qualification:**

- Consistently good academic record with first class marks (or an equivalent grade in a point scale wherever grading system is followed) in Master's degree in Business Management/ Administration/ in a relevant management related discipline or first class in two years full time PGDM declared equivalent by AIU/ recognized by the AICTE / UGC;

Or

First Class graduate and professionally qualified Chartered Accountant / Cost and Works Accountant / Company Secretary of the concerned statutory bodies.

- Ph.D. or Fellow of Indian Institute of Management or of an Institute recognized by AICTE and declared equivalent by the AIU.



- A minimum of ten years' experience of teaching / industry / research / professional out of which five years must be at the level of Reader or equivalent excluding the period spent for obtaining the research degree.

Or

- In the event the candidate is from industry and the profession, the following requirements shall constitute as essential requirements:
  - Consistently good academic record with first class marks (or an equivalent grade in a point scale wherever grading system is followed) in Master's degree in Business Management/ Administration/ in a relevant management related discipline or first class in two years full time PGDM declared equivalent by AIU/ recognized by the AICTE / UGC

Or

First Class graduate and professionally qualified Chartered Accountant/ Cost and Works Accountant/ Company Secretary of the concerned statutory body.

- The candidates should have professional work experience which is significant and can be recognized at national/ international level as equivalent to Ph.D. and twelve years' managerial experience in industry/ profession of which at least eight years should be at a level comparable to that of Reader/Assistant Professor.

**For Associate Professor and Professor:** Post Ph.D. publications and guiding Ph.D. student is highly desirable.
