The Chairman extended a warm welcome to all the members to the 27<sup>th</sup> Meeting of the Academic Council. He also extended a special welcome to the Chancellor, Dr. C.G. Krishnadas Nair. He informed that this meeting is primarily held to have discussions on the new UG programmes proposed to be introduced and the new syllabus, revised / fine-tuned Curriculum Matrix and Syllabus of ongoing UG programmes for the academic year 2018-19. Introduction of CBCS for PG programmes and additional new programmes shall be taken up in the next Academic Council meeting scheduled to take place in the month of May 2018.

The Chairman was very happy to inform the members that Jain University has been granted academic and financial Autonomy by the University Grants Commission (UGC) in March, 2018. He added that UGC has approved granting of autonomy to 52 Universities in different parts of the Country out of which 5 are from Karnataka State including our University. Jain University has been placed in the list of Category-II of the institutions eligible for graded autonomy as it secured "A" Grade with a CGPA of 3.31 in the NAAC Reassessment during June 2017. With this graded autonomy our University can initiate any new programmes, start open & distance-learning centers, hire foreign faculty and admit foreign students without seeking UGC's permission. Further, our University is also permitted to establish two campuses outside the State of Karnataka.

The Chairman thanked all the external and internal members for their constant unstinted support. He gave his special thanks to the President, Dr. Chenraj Roychand for constant motivation and the Chancellor, Dr. CG Krishnadas Nair for encouragement and guidance.

The members of Academic Council appreciated and expressed their happiness by congratulating all the Principal Officers, Faculty Members and Administrative Staff for this achievement.

The Chancellor expressed his happiness and congratulated all the Academic Council Members and Faculty Members of the University for securing graded autonomy under the leadership of the Vice Chancellor, Dr. N. Sundararajan. He advised the faculty members / senior officials of the University to continuously make efforts for further growth and carry out all the suggestions given by the UGC Expert Committee during December 2017. All the Departments / Research Centers must be compliant with the suggestions within 6 months. According to him, our University must explore in niche areas that benefit society and country. Further, innovative programmes introduced must be sustained and emphasized with more publicity. He also suggested to give more importance to research activities by conducting funded projects of National importance, publishing papers in journals with high impact factor and constantly interacting with leading labs / industries.

The Chairman was also happy to inform that the All India Council for Technical Education (AICTE) had recently taken a decision to grant approval to continue offering technical programmes such as B.Tech, M.Tech, MBA & MCA without on-site inspection for those Universities which were accredited by NAAC with a CGPA score of 3.26 and above. The Chairman informed that AICTE is going to scrutinize the documents submitted online and he requested the Registrar to give further details.

Dr. NVH Krishnan, Registrar stated that AICTE has made it mandatory for all the Universities to seek its approval for all the technical programmes offered by them. After the grant of graded autonomy, our University will get approval without on-site inspection. The online application is being made now with all the necessary documents like Curriculum Matrix & Syllabus of B.Tech, M.Tech, MBA & MCA programmes and details of infrastructure, faculty members and intake of students. AICTE is going to scrutinize all the documents on 18<sup>th</sup> of April, 2018.

After these introductory remarks, the Chairman took up the agenda items for discussion.

**Agenda item No. 1 - Confirmation of the minutes of the 26<sup>th</sup> meeting held on 10<sup>th</sup> February, 2018.**

The Chairman informed that in the last meeting detailed discussions were held with regard to review of Research Activities and the copy of the minutes was circulated to all the members. There was an observation made by Mr. A.K. Vora, Chairman, TATADLT, Pune on the minutes of the last meeting at the Discussion item – Agenda no. 3.1. The para given below need to be mentioned in the minutes as an additional suggestion made by him :

To create an Innovation Council consisting of : 1) A few select members of industry, 2) A few select eminent members from science and academic community who have hands on experience of successful innovation and breakthrough research resulting in

commercially exploitable products, 3) A few members of University management and 4) A couple of members of civil society who are passionate about crying needs of society via innovation.

The role of the Council would be to : 1) Provide industry & institutional connects and contacts facilitating collaborations, joint innovation projects, 2) Provide interface with needs of society and Industry, 3) Provide high level guidance and mentoring for R&D projects and 4) Provide / facilitate external validation at various stages of Innovation Projects.

The Chairman thanked Mr. A.K. Vora for the remarks on the Minutes and stated that the suggestion will be incorporated accordingly.

***The members gave their approval to confirm the minutes of the 26<sup>th</sup> meeting of the Academic Council held on 10<sup>th</sup> February, 2018 with incorporation of the suggestion cited above.***

**Agenda item no. 2 - Action taken report :**

**2.1. Formulation of Committee of Experts to carry forward and implement the suggestions formulated by the Academic Council in the last meeting.**

The Chairman mentioned that a Committee of Experts has already been formed to carry forward and implement the suggestions formulated by the Academic Council in the last meeting. The terms of reference for the work of the committee has been worked out. The Committee of Experts will be meeting soon and the dates will be finalized by 25<sup>th</sup> of April, 2018, to interact with every Department / Researcher.

***Members noted the action taken.***

**Agenda item no. 3: Discussion items :**

The Chairman informed that the proposals received for the seven new programmes have been placed before the Academic Council to discuss under agenda item 3.1.

Revised / fine-tuned Curriculum Matrix and Syllabus of ongoing UG programmes are placed under agenda items 3.2 (CBCS - 2016 batch), 3.3 (CBCS - 2017 batch), 3.3b (Revised / Fine-tuned syllabus), 3.4 (CBCS - 2017 batch B.Tech) and 3.4b (non-CBCS - 2016 batch B.Tech).

The proposal received for new programmes is a list of new programmes as on date and we may have additional new programmes for discussions in the next meeting during May 2018. This set of proposals was placed before Planning & Monitoring Board held on 10th March, 2018 for their consideration. After detailed discussion the Planning & Monitoring Board recommended to forward the suggested changes in the proposed Curriculum Matrix and modules to be incorporated in the syllabus of various programmes to the Board of Studies in the respective areas for the needful action.

The relevant background papers of all the agenda items, Curriculum Matrix & Syllabus of semesters I & II for all the new programmes and revised / fine-tuned Curriculum Matrix and Syllabus of ongoing UG programmes received from concerned Board of Studies have already been circulated and also placed on the table for ready reference of the Members.

The Chairman mentioned that while circulating all the background papers to the esteemed Members of Academic Council a covering note was made to kindly go through the documents and come with specific suggestions so as to have a point to point discussion and save time. As such there were only two replies, one from Dr. MJ Vinod and another from Dr. Mythili P Rao which will be discussed under the concerned agenda items.

**Agenda item no. 3.1 : To approve the new programmes proposed to be introduced for the Academic Year 2018-19 :**

The Chairman requested the Dean of concerned Faculty / Programme coordinator to give a brief background with respect to the proposed new programmes :

**Faculty of Commerce**

**1) B.Com (Hons) in Corporate Finance – Integrated with US CPA (Certified Public Accountants) + US EA (Enrolled Agents) (Global Taxation)**

Dr. Easwaran Iyer gave a brief background on the Course Objectives, Need & Scope of the course, Career path / Job opportunities and Potential employers for the new programme. He informed that the new programme has been integrated with US CPA (Certified Public Accountants) + US EA (Enrolled Agents) (Global Taxation). CPA & EA are the professional bodies which are going to recognize the programme. The students pursuing these courses will be trained to appear for examinations prescribed by them during Semester V or VI to get either membership or certification depending on clearing the subjects enlisted by the professional bodies and successfully completing B.Com. (Hons) in Corporate Finance. Well trained faculty members from CPA are going to train our students. He stated that intake is planned for 60. He presented the proposed Course Structure, Curriculum Matrix & Course contents of the new programme.

Dr. J. Uchil stated that the curriculum for the 3-year UG programmes have been framed in tune with CBCS pattern prescribed as per the UGC Guidelines.

There was a discussion with regard to the Eligibility Criteria for all the new programmes proposed. Dr. J. Uchil requested the Dean of concerned Faculty / Programme coordinator to submit the Eligibility Criteria for all the new programmes proposed. He suggested to have a difference between regular and honours programmes. Dr. CGK Nair opined that the eligibility criteria should be drafted carefully & not restrict only to cut-off in percentage of marks in the qualifying exams while selecting the candidates, and selection criteria can include capability and psychological tests.

Dr. Radhakrishna suggested to ensure that there is sufficient intake for all the new programmes that are going to be introduced.

### **Faculty of Management**

- 2) **BMS in Strategy & Leadership** – Integrated with US CSCA (Certified in Strategy and Competitive Analysis), IMA - USA and ILM-UK

Dr. Easwaran Iyer gave a brief background and presented the proposed Curriculum Matrix & Course contents of this new programme.

- 3) **BMS in International Marketing** – Integrated with Certified Digital Marketing Professional from Digital Marketing Institute of Ireland

Dr. Easwaran Iyer gave a brief background and presented proposed Curriculum Matrix & Course contents of this new programme.

### **Faculty of Humanities & Social Sciences**

- 4) **B.A (Hons) in Economics** – Integrated with the Royal Economics Society + Association of Certified Chartered Economists of UK

Dr. V.K. Xavier gave a brief background and presented proposed Curriculum Matrix & Course contents of this new programme. He mentioned that in BA programme existing now, Economics is one of the three optional subjects. The new programme BA (Hons) in Economics will specialize more in Economics, Financials, Quantitative Tools & Mathematics.

Dr. Xavier mentioned that the reply sent by Dr. Mythili P Rao in response to the background papers which were circulated have been considered. A few corrections suggested in the titles of the courses of the programme have been incorporated. The Internship which was

mentioned as one of the options in the Skill Enhancement Course shall be interchanged with a Core course.

Dr. J. Uchil suggested to provide an adequate bridge course for the subjects like Mathematics & Statistics for the selected candidates who did not have exposure to these subjects.

### **Faculty of Sciences**

#### **5) B.Sc (Hons) in Data Science and Analytics – Integrated with IoA (Institute of Analytics) + Institute of Mathematics + Royal Statistical Society of UK**

Dr. Vinod Murti gave a brief background and presented proposed Curriculum Matrix & Course contents of this new programme. The students will be inculcated with the ability to apply analytics techniques to analyze and interpret the data.

#### **6) B.Sc in Gaming – Integrated with International Moving Image Society, UK**

Mr. Dinesh Kulkarni gave a brief background and presented the proposed Curriculum Matrix & Course contents of this new programme. He highlighted on the need of this innovative programme and application techniques & methods and execution in the gaming industry. This programme is offered in India only to a limited extent.

Dr. Mythili suggested to ensure usage of original software for the educational purpose. Dr. Bhaskar Dixit suggested that progressive hardware capabilities must be used for the purpose of game testing.

Dr. Varalakshmi suggested to introduce PG Diploma in Gaming. The Chairman opined that once the B.Sc programme is sustained, the University can think of PG Diploma in the area of Gaming.

#### **7) Post Graduate Diploma in Information Technology**

Under University - Industry Interface programme with any one of the following options :

- a) Big Data (Industry partner Micro Focus)
- b) Cyber Security (Industry partner EC-Council)
- c) Cloud Technology with IoT (Industry partner Amazon Web Services Academy)

Dr. Suchithra gave a brief background and presented proposed Curriculum Matrix & Course contents of this new 1 year programme. She stated that intake is planned for 20 in each specialization. Prof. Sridhara Murthi suggested to give more weightage on the topics like Sensors.

The Chairman thanked Dr. J. Uchil for scrutinizing all the new programmes during the Boards of Studies meetings by giving suggestions and guidance.

**Agenda item no. 3.1b : Introduction of B.Sc. in Biochemistry, Genetics & Biotechnology (BcGBt) a new combination with CBCS pattern from 2018-19. New Syllabus of Biochemistry & Genetics papers for Semesters I & II.**

The Chairman mentioned that there was a demand for the new combination for B.Sc in Life Sciences with options in Biochemistry, Genetics & Biotechnology (BcGBt) in addition to the existing combination Chemistry, Microbiology & Biotechnology (CMBt). In this regard the Curriculum Matrix for BSc in BcGBt drafted with CBCS pattern along with new syllabus for Biochemistry & Genetics of Semesters I & II have been placed for approval. He requested the members to also approve the new combination B.Sc in BcGBt to introduce from the academic year 2018-19.

***The Chairman informed that the suggestions and feedback given by the members need to be incorporated in the Curriculum Matrix and Syllabus of these new programmes.***

***Members accorded approval for introduction of new programmes proposed for the academic year 2018-19, subject to the incorporation of the suggested changes in the Curriculum Matrix / Syllabus.***

The meeting concluded with a vote of thanks.






