The Chairman extended a warm welcome to all the members and special invitees to the 32<sup>nd</sup> Meeting of the Academic Council.

The Chairman took up the agenda items for discussion.

**Agenda item No. 1 - Confirmation of the minutes of the 31<sup>st</sup> meeting held on 27<sup>th</sup> July, 2019.**

The Chairman informed that the copy of the minutes was circulated to all the members and that there were no suggestions / observations received in this matter. He requested the members to confirm the minutes of the last meeting.

***The members confirmed the minutes of the 31<sup>st</sup> meeting of the Academic Council held on 27<sup>th</sup> July, 2019.***

**Agenda item no. 2 : Action Taken Report :**

The Chairman mentioned that the following action plans have been initiated which were approved by the Academic Council in the last meeting :

- (i) Action plans for extension of Outcome Based Education for non-professional academic programmes implemented and
- (ii) Follow-up of the new UGC Regulations and Evaluation Reforms – awareness creation.

***Members noted the action taken.***

**Agenda item no. 3 : Discussion items :**

**Agenda item no. 3.1 : Approval of Modified / New Regulations for academic programmes 2019-20.**

The Director (Academics and Planning) informed that the following Regulations for the on-going academic programmes have been updated :

- Uniform Regulations for UG programmes
- Uniform Regulations for PG programmes
- Regulations for B.Tech programmes
- Regulations for M.Tech programmes
- Regulations for MBA programmes
- Regulations for MCA programmes

He mentioned that the above modified versions comprehensively incorporate all changes that were effected and adopted earlier for these programmes owing to the renewal of the programmes on introduction of the Choice Based Credit System (CBCS) or compliance with guidelines of UGC / AICTE. The updated copies of the Regulations have been circulated to the members for perusal.

Dr. Mythili P Rao suggested that in the uniform Regulations for UG programmes, Foreign languages offered as electives for the students may be indicated in the para no. 2.1 along with Indian languages that are also offered to them.

Dr. M.J. Vinod observed the attendance parameters are distinct for UG and PG Regulations. He appreciated the need for more weightage of attendance to UG students, as PG students will be oriented towards seminars, presentations and other activities.

The Director (Academics and Planning) also informed that the following are the new Regulations for the academic programmes for the AY 2019-20 :

- Regulations for B.Des programmes
- Regulations for M.Des programmes

These new Regulations have been proposed for Bachelor of Design (B.Des.) and Master of Design (M.Des.) programmes, having regard to the innovations in pedagogy and programme design. He informed that new Regulations for B.Des and M.Des have been drafted to strictly adhere to the AICTE norms. The copies of the new Regulations have been circulated to the members for perusal.

Dr. Ghosal briefly highlighted on the assessment of the subjects which fall under the categories of skill, studio, theory and projects. The student is evaluated intensively by jury, whereby the jury consists of at least one faculty member from the subject specific discipline and two faculty members from other disciplines. He also highlighted that the Regulations also specify things that are not to be designed in the D-School, from ethical point of view.

Dr. Gururaja suggested to create an awareness mechanism to convey the Regulations to the students in a comprehensive manner.

The Chairman stated that all the suggestions given by the members will be taken into consideration and requested them to approve the Regulations. There are three aspects which need to be given attention to as follows : (a) important role of implementation, (b) harmony and compliance with higher regulations and (c) an independent monitoring system.

***Members approved the modified / new regulations of the academic programmes for the AY 2019-20.***

**Agenda item no. 3.2 : Accomplishments of the Research / Innovation Centres post accreditation.**

The Chairman informed the members that a special agenda has been prepared to discuss on the research activities undertaken by our University post accreditation, by the NAAC during July 2017. He requested the Heads of the following Research / Innovation Centres to make presentations and the members to have an open discussion and interaction :

- (i) Centre for Nano and Material Sciences (CNMS)
- (ii) Fire and Combustion Research Centre (FCRC)
- (iii) International Institute for Aerospace Engineering and Management (IIAEM)
- (iv) Centre for Research in Social Sciences and Education (CERSSE)
- (v) Centre for Ancient History and Culture (CAHC)
- (vi) Research at Centre for Post Graduate Studies (CPGS)
- (vii) Jain University Incubation Centre (JUIC)

**Centre for Nano and Material Sciences (CNMS) :**

Dr. Geetha Balakrishna made a presentation with regard to the Centre for Nano and Material Sciences (CNMS). She highlighted on the areas of Doctoral Research programmes, facilities used for the research, projects, research collaborations and research outputs by researchers of the centre. External Members at the outset highly appreciated and commended the extensive research accomplishments particularly in nationally important areas like Energy, Water and Health by the centre.

Responding to the challenge of sustaining the momentum of research, Dr. Natarajan suggested to explore for sponsorships and fellowships from Indian National Academy of Engineering (INAE) and Indian National Science Academy (INSA). He also mentioned to continue focus on high quality research as suggested in the draft National Education Policy, 2019 through interdisciplinary / multidisciplinary approach.

Dr. Gururaja expressed on the following three important aspects to be considered for further growth of research : (i) Communicating the research work to outsiders through a competent spokesperson to reduce such burden on R&D resource persons, (ii) Pursue other avenues to mobilize resources particularly where large funding is visible (such as solar energy field) and (iii) Seek funds as donations for corpus build up & developing strategy to access international collaborations.

Members highly appreciated the research work done and the facilities available at the CNMS.

**Fire and Combustion Research Centre (FCRC) :**

Dr. Bhaskar Dixit made a presentation with regard to the Fire and Combustion Research Centre (FCRC). He highlighted on the Facilities utilized for the Research activities, State of the art indoor fire testing Lab, Projects, Research collaborations and Research outputs the Centre.

Dr. Natarajan suggested to look for collaborations with The Combustion Institute, which is an international scientific & engineering society that promotes research in combustion science, for attractive research proposals. He also suggested to conduct research in propulsion along with NAL / GTRE – Combustion Group. Dr. Bhaskar Dixit clarified that the centre has already established contacts with The Combustion Institute and shall pursue regarding research proposals.

Dr. Gururaja stressed to consider research work in areas of contemporary interest like forest fires and also other aspects connected to fire hazards in automobiles.

Members were also highly appreciative of unique nature of research and industry interface activities carried out by the FCRC.

#### **International Institute for Aerospace Engineering and Management (IIAEM) :**

Dr. Antonio Davis made a presentation with regard to the International Institute for Aerospace Engineering and Management (IIAEM). He highlighted on the innovative academic programmes, facilities utilized for the research activities, projects, research collaborations and research outputs by researchers of the centre.

Dr. Natarajan suggested to take up research activities in the area of Micro Air Vehicles (MAVs) and Technology projects sponsored by the Society of Automotive Engineers (SAE). He contemplated on the challenge of placement of future batches of students from IIAEM and insisted that the students should be updated with additional skills in software / coding etc.

Dr. Gururaja mentioned that the demands for research to be explored and proposals should be generated with request for grants. Research should be demand driven and innovative in nature.

Members appreciated various research activities at IIAEM specifically on structural health monitoring and focus on aviation safety.

#### **Centre for Research in Social Sciences and Education (CERSSE) :**

Dr. Sandeep Shastri made a presentation with regard to the Centre for Research in Social Sciences and Education (CERSSE). He highlighted on the thrust areas of research, projects, consultancies, research collaborations and research outputs by researchers of the centre. He also informed that a book authored by him titled “Lal Bahadur Shastri – Politics and Beyond” is going to be released on 17<sup>th</sup> October in Delhi and 25<sup>th</sup> October, 2019 in Bengaluru.

Dr. Natarajan suggested to approach MS Ramaiah Public Policy Center (RPPC) and Institute for Social & Economic Change (ISEC) for association. He also suggested that the centre should pursue on Liberal studies. Dr. Sandeep Shastri clarified that the centre has already established contacts with RPPC & ISEC and shall look to establish further research proposals. He also clarified that the centre is responsible for handling Generic Electives in academic programmes across the disciplines.

Dr. Gururaja suggested to undertake projects on democracy / governance policy in India, with a global appeal, i.e. Democratic Liberalism, for example.

The Members expressed appreciation for the preeminent position which the centre has achieved in the social sciences research and its extensive collaborative endeavors.

#### **Centre for Ancient History and Culture (CAHC) :**

Dr. R.N. Iyengar made a presentation with regard to the Centre for Ancient History and Culture (CAHC). He highlighted on the thrust areas of research and research outputs by researchers of the centre. He also informed that Jain University Press had published a book called “Narada Silpasastra” - an Ancient Sanskrit text on Architectural Civil Engineering authored by Prof. R. N. Iyengar, assisted by his colleagues, Dr. K. S. Kannan and Dr. S. Y. Wakankar and the book was released during June, 2018.

Members appreciated the research work with regard to documentation of ancient literature at CAHC and Dr. Gururaja suggested that its authenticity is highly valuable and should be enhanced.

#### **Research at Centre for Post Graduate Studies (CPGS) :**

Dr. Varalakshmi made a presentation with regard to research activities of the School of Sciences Block I - Centre for Post Graduate Studies (CPGS). She highlighted on the areas of Doctoral Research programmes, thrust areas of research – Physical Sciences and Life Sciences, facilities used for the research, projects, research collaborations and research outputs by researchers of the centre. She informed that Dr. B.S. Kumudini has been awarded the Smt. Guman Devi Verma Memorial Best Woman Scientist Award – 2019 (Commendation) by the Indian Society of Mycology and Plant Pathology.

Members appreciated the award recipient and for the conduct of high quality research work in addition to the academic programmes at CPGS.

#### **Jain University Incubation Centre (JUIC) :**

Mr. Nayaz Ahmed made a presentation on Jain University Incubation Centre (JUIC) and Chenraj Roychand Centre for Entrepreneurship (CRCE). He highlighted on entrepreneurship, education & Research, Technology Business Incubation on various business verticals, major activities like nationwide Makeathon - a 36-hour design, coding and implementation and Hackathon – creating socially relevant innovative ideas.



Dr. Gururaja suggested to have a focused marketing by inculcating industrialists to invest in startups. He also suggested to utilize the knowledge in other centres of the University for incubating ideas for innovations.

Members appreciated the efforts made for commercializing R&D outputs through technology business incubation at the JUIC.

***The Chairman remarked that the exclusive discussions on the research / innovative activities have given an opportunity for all to know the extensive research being taken in the University. This brainstorming session and suggestions by the expert members shall enhance the quality in research of the University. He thanked all for the active participation.***

**Agenda item no. 3.3 : To approve the Revision of Curriculum of the PhD Programme for AY 2019-20.**

Dr. Sandeep Shastri presented the Curriculum revised for the following 32 PhD specializations by the concerned Boards of Studies:

Dr. Shastri briefly explained the recommendations made by the respective BoS on the changes made in Syllabus for the Courses on Research Methodology, Core Paper and Specialization Paper 1 and Specialization Paper 2 that are offered in the PhD Programmes.

***After due consideration, the Academic Council approved the revised Curriculum for the PhD programme which are effective from the academic year 2019-20.***

#### **Agenda item no. 4: Reporting Items :**

##### **Agenda item no. 4.1 : Conduct of Academic and Administrative Audit (AAA) - AYs 2017-18 & 2018-19 on 16th October, 2019.**

The Chairman informed the members that both UGC and NAAC have prescribed Academic and Administrative Audit involving internal and external reviews of the institutional processes as an essential tool in Higher Educational Institution for achieving excellence. In order to fulfill this requirement, the Academic & Administrative Audit of the University for the years 2017-18 and 2018-19 was taken up. Accordingly, a format in which necessary information required to facilitate the audit was circulated to all the Directors / Heads of Centers. The Center Directors were requested to review the information submitted with the assistance of their teams and submit a consolidated report at each school level or dedicated research center level, including a SWOC (Strength, Weakness, Opportunities and Challenges) analysis and actions taken as follow up of previous audit and future plans. The SWOC analysis was validated by the IQAC. Then, he requested Dr. Sandeep Shastri to give further details on the conduct of AAA and action plan to review AAA documents with external experts.

Dr. Sandeep Shastri informed that the **Academic & Administrative Audit (AAA) of the University for the AYs 2017-18 and 2018-19 by an External Committee is scheduled on 16<sup>th</sup> October, 2019** at the JP Nagar campus. A briefing meeting was held with the Heads / Deans of Faculties and Directors of dedicated Research centers on 27th September, 2019 and the Methodology for the conduct of AAA was discussed. During the Audit there shall be a University overall presentation by the Vice Chancellor, Faculty-wise and Research centres presentations by the respective Heads, followed by presentations on

Administration & Governance, IQAC, Examination System and Extension Activities. The presentations shall depict the Strength, Weakness, Opportunities and Challenges (SWOC) analysis and the inputs received on the number of faculty members, departments, programmes / research activities etc.

***Members noted the initiatives taken for the conduct of AAA by the University on 16th October, 2019.***

**Agenda item no. 4.2 : Conduct of Annual Research Retreat on 23rd and 24th November, 2019.**

Dr. Sandeep Shastri informed that the Annual Research Retreat of the University is scheduled on 23<sup>rd</sup> and 24<sup>th</sup> November, 2019 at the Jayanagar 9<sup>th</sup> Block campus. He added that all the research scholars will be presenting their progress of the research work which will be reviewed by the experts.

***Members noted the conduct of Annual Research Retreat by the University.***

**Agenda item no. 4.3 : ISO 9001:2015 – QMS, 2nd stage Audit by TUV NORD was held on 17-09-2019.**

The Chairman informed that the ISO 9001:2015 – QMS, 2nd stage Audit by TUV NORD was held on 17-09-2019 and the University received a positive appreciation.

***Members noted the details with regard to ISO Audit.***

**Agenda item no. 4.4 : KSURF Rankings, 2019 – 5 Star ratings, Jain (Deemed to be University) is ranked top 2 among young Universities in Karnataka.**

The Chairman mentioned that the University is ranked top 2 among young Universities in Karnataka and also obtained a 5 Star rating by Karnataka State Universities Rating Framework (KSURF) Rankings, 2019. Our University scored 789 out of 1000 and CGPA 4.15 out of 5.

***Members noted the rankings by KSURF to the University and appreciated the recognition.***

**Agenda item no. 4.5 : Initiatives for foreign students.**

The Registrar informed that with the initiative of ‘Study in India’ programme by the Ministry of Human Resource Development has invoked the foreign students towards an

attractive education destination in India. The University has around 984 international students enrolled for various programmes for the AY 2019-20. Considering the challenges faced for the delayed and staggered admissions by the international students and their poor English language ability, following initiatives have been taken by the University to overcome the problems. (i) Bridge courses comprising English and Soft Skills shall be delivered over a duration of 2-3 weeks (ii) A separate calendar shall be drawn up for the 1st two Semesters commencing in September. The schedule has been drawn up such that it will enable them to be in synchronised with the regular batches before commencement of the 3rd semester.

***Members noted with appreciation the initiatives taken for foreign students.***

**Agenda item no. 4.6 : Implementing Computer Based Assessment in certain courses as a measure of Reforms in the Examination System.**

The Registrar informed that further steps have been taken with regard to the Examinations Reforms. The University will be implementing Computer Based Assessment in following courses as a measure of Reforms in the Examination Systems :

1. Environmental Studies
2. Mind Management & Human Values
3. Computer Fundamentals
4. Indian Constitution / Constitution of India
5. Diploma Mathematics I
6. Diploma Mathematics II

Multiple Choice Questions (MCQ) based examinations will be conducted after the completion of each module for these courses. The Software has been designed to generate unique Question papers for any number of students of these courses. With this, the results can be declared instantly and the students shall improve the pleasure of learning.

***Members concurred with implementing Computer Based Assessment in certain courses as a measure of Reforms in the Examination Systems.***


**Agenda item no. 5: Any other matter with the permission of Chair :**

**• Meetings of Boards of Studies (BoS) – UG & PG Programmes – 2020-21.**

The Director (Academics and Planning) mentioned that it is mandatory to inform the UGC with regard to the new programmes introduced during the given academic year before the month of April, i.e. the new programmes approved by the Statutory Bodies

for the AY 2020-21 should be informed to UGC before April 2020. Also, it is mandatory to inform the AICTE the new professional programmes before December, 2019 to be introduced during AY 2020-21. In view of this, Meetings of Boards of Studies of the respective departments need to be held before 31<sup>st</sup> October, 2019 and a notification will be sent all the Chairpersons of the concerned BoS to recommend the new programmes for 2020-21. Once the recommendations of BoS are perused by the Standing Committee, the meetings of Planning & Monitoring Board, Academic Council and Board of Management will be held for final approval during November / December 2019. Further, the Boards of Studies are advised to include agendas to consider revision of the existing Syllabus in all cases where the earlier revision to the prescribed time cycle is completed (i.e. every 2 years in case of all PG Programmes, every 3 years in case of all 3-year UG programmes & MCA programmes and every 4 years in case of B.Tech programmes) and Fine tuning of the syllabus of the ongoing programmes wherever necessary. BoS are also requested to submit the detailed syllabus for the ongoing degree programmes for subsequent higher semesters that are coming for AY 2020-21 as per the approved Curriculum Matrix.

**The meeting ended with the Director (Academics and Planning) thanking the Vice Chancellor for ably chairing the meeting and conducting the proceedings smoothly. He also thanked all the presenters, external members for their valuable suggestions and other members for their proactive participation.**
