The Chairman extended a warm welcome to all the members and special invitee to the 29<sup>th</sup> Meeting of the Board of Management (BoM). He also extended a special welcome to the Chancellor, Dr. C.G. Krishnadas Nair.

The Chairman took up the agenda items for discussion.



Agenda item No. 1 – Confirmation of the minutes of the 28<sup>th</sup> meeting of the BoM held on 11<sup>th</sup> May, 2019.

The Chairman informed that the copy of the minutes was circulated to all the members and that there were no suggestions / observations received in this matter. He requested the members to confirm the minutes of the last meeting.

The members confirmed the minutes of the 28<sup>th</sup> meeting of the Board of Management held on 11<sup>th</sup> May, 2019.

Agenda item no. 2 - Action taken report :

Ratification of the resolutions and action taken by the Standing Committee during June and July 2019, as follows:

- i. <u>68<sup>th</sup> Meeting of the Standing Committee held on 29<sup>th</sup> June, 2019.</u>
  - a) The Chairman informed that the Standing Committee had reviewed the status on the New Programmes approved and introduced during the AY 2019-20 which were accorded sanction in the last meeting of the Board of Management.
  - b) The Standing Committee had discussed on the Academic and Administrative Audit for the AYs 2017-18 and 2018-19. The Chairman informed that as prescribed by UGC and NAAC, preliminary data has been collected in a required format for Academic and Administrative Audit from the Directors / Center Heads. IQAC team has consolidated the information received and has prepared the SWOC analysis. Dr. Sandeep Shastri has been requested for reviewing the reports. Later on, the Academic and Administrative Audit will be conducted by involving external experts in August, 2019 for the AYs 2017-18 and 2018-19. The Chairman added that the Academic component of Audit will be coordinated by the Director (Academics & Planning), while the Administrative part of Audit by the Joint Registrar and Registrar. Other important aspects for Audit are Examination Reforms, ERP, Extension activities, University administrative activities and IQAC activities whose reports have been separately collected.
  - c) The Standing Committee had preliminary discussions on the conduct of 9<sup>th</sup> Annual Convocation of the University, which will be taken for discussion under the Agenda no. 4.

### ii. 69<sup>th</sup> Meeting of the Standing Committee held on 24<sup>th</sup> July, 2019.

a) The Standing Committee had discussed with regard to the Deemed to be Universities Regulations - 2019 notified by UGC on 20th February, 2019. The Chairman informed that all the important changes in the Regulations - 2019 compared to that of 2016 have been taken into account and the University is trying to achieve them. He added that the principal change in the Regulations 2019 is the shift in emphasis from "maintenance of standards" to "performance obligations" and "public disclosure". A brief note on the Regulations – 2019 is placed before the members for reference. In terms of the 2019 Regulations, UGC shall be monitoring the performance and academic outcomes of Deemed Universities annually based on public disclosures. The compliance of the action taken will be made available on a public domain and all the details pertaining to the parameters will be uploaded in our University website year on year. Awareness programme to discuss on the essence of quality education as per UGC notification is scheduled with all the Center Heads / Deans / Directors on 7th



August, 2019 and this kind of awareness programme will be conducted at least once in a month.

- b) The Standing Committee had discussed with regard to the Evaluation Reforms in Higher Education Institutions (HEI) in India Recommendations notified by UGC on 22nd February, 2019. The Chairman mentioned that the current status on the key recommendations of the Evaluation Reforms 2019 initiated by UGC has been summarized and circulated to the members. The Evaluation Reforms by the UGC is intended to draw attention to priority areas, and provide ways and means to improve the methods in conduct of evaluation, hence, it is necessary to link evaluation to learning outcomes. One of the major recommendations is the learning under Outcome Based Education framework. He stated that most of the Evaluation Reforms 2019 has already been implemented by the University. The compliance of the action taken will be made available on our website. A workshop to discuss on the Evaluation Reforms as per UGC notification is scheduled with all the Center Heads / Deans / Directors on 7th August, 2019.
- c) The Standing Committee had discussed with regard to extension of Outcome Based Education to non-professional programmes. The Chairman informed that the University had taken initiative of implementing Outcome Based Education (OBE) practices already in professional programmes of the University including MBA, MCA, B.Tech and M.Tech which comply with the standards of the National Board of Accreditation (NBA). Through the notification No. F.1-2/2018 (CPP-I/DU) dated 20th February 2019, the UGC has included OBE among the performance and academic outcomes of Deemed to be Universities for all programmes of such universities. OBE also forms an integral part of NAAC parameters. In light of these, steps are being taken to implement OBE for all other programmes too in the University. In contrast to the traditional approach of emphasizing the curriculum and delivery from inputs perspective, with teacher at the centre stage, OBE method requires defining and focusing on what all the students should be able to do successfully at the end of their learning experiences and accordingly organizing all educational activities. Knowledge sessions in this regard are being conducted at each Centre for all faculty members in participation with the Heads of the Departments and Deans / Directors. The strategy for implementing OBE is through five steps - Defining, Designing, Delivering, Documenting and Determining. It is significant to note that methodological steps, aided by digital technologies had been developed to assist faculty in both the definition as well as assessments for determination of attainment. Subsequent to the knowledge sessions, the Deans / HoDs / Faculty members will converge to identify and define Topic Learning Outcomes (TLO's) from the curriculum, the Program Outcomes and Course Outcomes in about a



month's time. One of the innovative elements to be implemented by the University is greater reliability, timelines, and economy through the use of ERP system for deriving Program Outcomes and Course Outcomes linkage matrix automatically based on initial inputs of teachers and automated calculation of attainment. Thus actions are contemplated to implement OBE in compliance with the requirements.

- d) The Standing Committee had reviewed on the draft new National Education Policy - 2019 framed by the Ministry of Human Resource Development, Gol which gives a new and forward looking vision for India's Higher Education System. As a necessary requirement a presentation and discussion was organized by the University on the Draft New Education Policy on 19th June 2019 at the Palace Road campus. One of the key members of the Drafting Committee and a key Coordinator of the Technical Team of the New Education Policy Committee, Dr MK Sridhar gave his views and discussed on the said policy. All the Directors of the constituent units along with deputed faculty members from their campuses attended this important interaction and received good clarity during the session. The Chairman congratulated Dr. Sandeep Shastri for taking this initiative. It was also noted and appreciated that Dr. Sandeep Shastri was one of the Eminent Persons consulted by the Committee which drafted the National Education Policy - 2019 under the chairmanship of Dr. K. Kasturirangan, Former Chairman, ISRO. Our University views on the National Education Policy - 2019 have been prepared and sent to AIU and NAAC.
- e) The Standing Committee had discussed on moving towards Paperless Administration to be implemented in our University from the AY 2019-20. The Chairman informed the members that as per the recommendations by the NAAC, our University is planning to move towards Paperless Administration to be implemented from the AY 2019-20. In this regard a brief note on paperless administration has been circulated to all the members for reference. He requested the Registrar to make a presentation on the paperless administration.

The Registrar briefly highlighted on the following aspects which are made online - admission process, admission approval, creation of curriculum matrix, student attendance, student feedback, auto completion of application for student's examination and result analysis. Programme coordinators are given access to create course matrix & input the student details and all the necessary approvals will be done online at the University Administrative office. He mentioned that paperless administration in our University is aiming to have a work environment in which the use of paper is eliminated or greatly reduced by 85% to 95%. A road map to Paperless Administration is possible through - formation of a team, using



only online dynamic reports or centralized MIS reports, having student's portal and faculty portal, defining frequency of management reports and using emailers. As per the Recommendations on Evaluation Reforms made by UGC, our ERP system has been programmed to draw question papers from the question bank and every year 20% new questions are added to the questions bank.

Dr. GSD Babu suggested to take care of the confidentiality in the computer systems that shall allow only authorized users to access sensitive and protected data. Dr. R.S. Deshpande added that password protection must be of at least 2 levels and the server should be installed with anti hacking software. All the members appreciated the implementation of ERP and moving towards paperless administration.

Members ratified the resolutions and actions taken by the Standing Committee at its 68<sup>th</sup> and 69<sup>th</sup> meetings.

## Agenda item no. 3 - To approve the list of successful candidates for the award of Ph.D. Degree.

The Chairman requested Dr. Sandeep Shastri to place before BoM the list of successful candidates eligible for PhD degree who were recommended by the PhD Registration committee.

The Chairman suggested to send the copies of the PhD notifications for the award of PhD degrees to AIU on a regular basis.



The Chairman requested the Members of BoM to approve the present list of 19 successful candidates for the award of Ph.D through University Notifications.

Members accorded their approval to the list of 19 successful candidates for the Notifications for the award of PhD Degree.

Agenda item no. 4 - Discussion items:

Agenda item no. 4.1 : Conduct of 9<sup>th</sup> Annual Convocation of the University on Monday, 26<sup>th</sup> August, 2019.

Agenda item no. 4.2: To approve the lists of eligible Graduates, Postgraduates and Ph.D candidates for the 9<sup>th</sup> Annual Convocation.

Agenda item no. 4.3: To approve the list of Rank Holders and Gold Medalists.

The Chairman informed the members that 9th Annual Convocation of the University is scheduled to take place on Monday, 26<sup>th</sup> August, 2019 at 4.00 pm. Dr. K. Sivan, Chairman, Indian Space Research Organization (ISRO) has consented to be the Chief Guest for the Convocation.

The Chairman further presented the provisional list of eligible candidates for  $9^{th}$  Convocation. As on date, a total of 3424 graduates are eligible to receive their degrees in the  $9^{th}$  Annual Convocation. Out of this 170 are rank holders (PG - 78 and UG - 92) including 76 gold medalists (1 gold medal is for excellence in sports). The Chairman provided a bifurcation of the 104 candidates who are eligible for the PhD degree during the 9th Convocation according to each faculty, as follows:

The Chairman informed that as an experimental basis a few major changes are being made for the conduct of 9th Convocation. This time only PhD scholars, Gold Medalists and Rank Holders are being invited to receive their degrees in person that comes to



around 300 candidates. The venue has been proposed in the Bengaluru City. Chowdiah Memorial Hall has been chosen since it is one of the prominent auditoriums which will accommodate around 1,200 invitees (candidates and their parents) and this will also reduce the travel time, transportation and lunch costs. The convocation function is going to commence from 4.00 pm and concludes by 6.30 pm. As per the UGC circular the graduating students are advised to wear traditional dress with a preferred colour code during the convocation ceremony. Sash made of pure silk incised with University logo would be draped over the candidates' shoulders during the convocation programme, later on the sash can be taken by them as a memorable gift. The convocation programme shall include classical Nadhaswaram, Veda Ghosham and Honours with the Karnataka State Anthem.

The Chairman congratulated the Controller of Examinations for doing a commendable job in compiling and providing all the necessary documents to the Board of Management.

He added that necessary arrangements have been taken care by the Director (Projects & Facilities) and the Joint Registrar along with the Controller of Examinations and the Advisor (Examinations Unit). Special arrangements shall be made for media persons covering the convocation programme.

Immediately after the Convocation, an alternative arrangement will be made to issue Degree Certificates to other graduating candidates at the respective centers in a specially arranged Graduation Day function.

The Chancellor pointed out to look into the cost estimation of sashes which are proposed for distribution to all the graduating students and workout sustainability in the long run. Prof. E.S. Dwarakadasa suggested to mention year of the Convocation on the sash close to the University logo, in case the sash are handed over to all the graduates after the convocation.

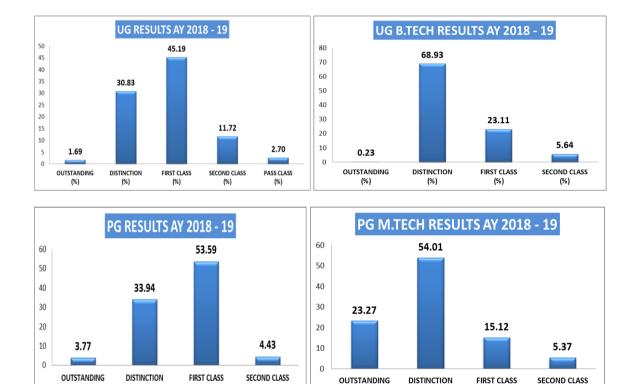

#### Agenda item no. 5.2 - External / Statutory Audit for the Year: 2018-19

The Chairman informed the Members that the Statutory Auditors (External) of the University would be auditing the University operations from 21/09/2019. The Internal Audit Observations and Actions taken would also be presented to the Auditors for review/ratification. The Auditors Report along-with the observations, if any, would be presented in the ensuring Board of Management Meeting.

The Members noted all the reporting items.

Agenda item no. 6 – Any other matter with the permission of the Chair.

- 1. The Chancellor discussed with regard to the following:
  - i. He suggested that the faculty members at School of Engineering to take up outreach programs / new projects funded by outside agencies or Government bodies for developing rural areas, as goodwill to serve our society and nation. Eg: To undertake projects in water purification and measuring quality of water, To develop techniques for smart agriculture etc.
  - ii. He expressed his vision for Jain (Deemed to be University) to become the first private university in India to build solar electrical energy at our global campus.
  - iii. He emphasized on the Corporate Social Responsibility and Social Accounting. He suggested to develop a model for social accounting and ethical sustainability balance sheets.

Members endorsed the suggestions made by the Chancellor. The Chairman welcomed the suggestions and mentioned that these suggestions need to be discussed at length with background details which can be taken up as a special agenda for discussion in the next Board of Management Meeting.

2. The Chairman informed that the next meeting of Board of Management is tentatively proposed on Saturday, 12<sup>th</sup> October, 2019 and requested all the members to make a note of the date.

The meeting concluded with the Registrar giving vote of thanks and expressing his gratitude to the Chancellor for his valuable views, the Chairman for the smooth conduct of the meeting and other members for their active participation and inputs.
